- 3.20 To purchase or hire or to take the lease lands, buildings and other immovable or movable properties in the name of the Trust.
- 3.21 To take over the management of any other public or charitable institutions, projects or branch of any such institution on such terms and conditions as the Trustees may deem fit and to manage such institutions.
- 3.22 To acquire by gift, purchase, exchange lease or hire or otherwise any lands, buildings any other property movable or/and immovable and any estate or interest for the furtherance of all or any of the objects of the Trust.
- 3.23 To create any reserve fund, sinking fund, insurance fund, provident fund or any other special fund whether for depreciation or repairs for improving, extending or



3.24 To do all such other lawful acts deeds or other things either alone or in conjunction with other organizations as are incidental or conducive to the attainment of any of the above objects.

3.25 To provide the welfare of the employees of the Trust.

3.26 The trust shall be kept free from the political atmosphere. It shall establish comparative studies in oriental and occidental learning and will promote adult education irrespective of caste, creed or religion.

3.27 To make rules and regulations for the conduct of the Trust and to add, amend, vary or rescind them from time to time.

3.28 All activities financed from the fund shall be conducted in accordance with the ideals and objects as stated herein and no discrimination shall be permitted therein on grounds of religion, caste, creed or sect. Provided that any donation earmarked and accepted for any specific purpose falling within the objects mentioned in these presents shall be used for such specific purposes.

3.29 To accept upon such terms as the board of Trustees may think fit and grant donations or contributions in money, kind or land or other property impressed with the Trust to carry out the objects referred to in sub clause 3.1 to sub clause 3.28.

Provided that the terms upon which such grants donations contributions shall be accepted shall not in any way be inconsistent with or repugnant to the objects of the present.

- 4 Shri Bishwanath Choudhary S/o Late Dwaraka Prasad Choudhary resident of Barahat P.S. Barahat Dist. Banka (Trustee)
- 5 Shri Awadhesh Kumar Singh S/o Shri Rampal Singh resident of Dalia Post & P.S. Bounsi Dist. Banka. (Trustee)

The member Trustees shall be Trustees for a period of two years from the date of creation of the Trust and on the expiry of the duration of two years, the Managing Trustee shall appoint member Trustees in place of outgoing Trustee.

4.4 Appointment of New Trustees:

If and when as the present Trustees of these presents die or desire to retire or refuse to work or become incapable to act in the Trust or to take the benefit of insolvency law for the time being in force or lose nationality or become of an unsound mind, disqualified by operation of law or if any Trustee without leave remains absent from six consecutive meeting of the board of Trustees, then in every such case it shall be lawful for the Managing Trustee to appoint new Trustees in place of the Trustees so leaving or desiring to retire or refusing to work or becoming incapable to act or taking the benefit of the insolvency law, or failing to attend six consecutive meetings of the Trustees without leave. Any Trustee so appointed shall always be an Indian. Any vacancy out of permanent Trustees will hereafter be called vacancy of permanent Trustees. The Managing Trustee shall have power to fill up vacancy in the board of Trustees by nominating/ appointing any other person. Even the outgoing Trustees may be re-appointed as a Trustee.

4.5 EFFECTS OF APPOINTMENT OF NEW TRUSTEES

Upon every appointment made in pursuance of the last foregoing clauses thereof the newly appointed Trustees shall have all powers and authorities of the outgoing Trustees under these presents.

It shall be lawful for the Managing Trustee to settle and determine all matter of difficulty, doubt or dispute and all questions arising in the course of or incidental to the administration management of the Trust and power under execution of the Trust and power under THESE PRESENTS and any such settlement or determination (although the questions involved may not have been actually raised) shall be valid, binding and conclusive and shall not be objected to or re-opened upon any ground whatsoever except in accordance with the decision by the Patron as mentioned in clause 5.

6.6 TO SELL THE IMMOVABLE PROPERTY AND MANAGE

The Trustees may sell or assign any movable or immovable property except the initial corpus of the trust which in schedule 'A' or properties for the time being forming part of the Trust fund either together or in parcels and either by public auction or private contract and either with or without any special or other stipulations as to title, evidence or commencement of title or otherwise and may buy/ and rescind or vary contract for the sale and resale without being made answerable for the loss

8. FUNCTIONS AND DUTIES OF THE OFFICE BEARERS

8.1 FUNCTIONS AND DUTIES OF THE MANAGING TRUSTEE

- i) He will in every meeting submit the report of the working of the Trust and its units along with detailed statements of receipts and expenditure and cash and Bank balance for the consideration by the Trust.

8.2. FUNCTIONS OF THE JOINT MANAGEMENT TRUSTEE

- a) He shall discharge all the functions of the Managing Trustee in absence of the Managing Trustee and also discharge such other functions as may be delegated by the Managing Trustee in writing.

9.0 ACCOUNTS AND YEARS

9.1 ACCOUNTS AND AUDITS

The Trustee shall get maintained regular accounts of the Trust Fund and shall get the same duly audited by a competent chartered accountant. The accounts and audit reports and the reports of the Trustee shall be published at least once a year.

9.2 The accounts of the Trust would be closed and balanced on 31st March.

10.0 MEETING AGENDA QUORUM

10.1 Meetings


All meetings of the Trust shall be called by the Managing Trustee.

10.2. Decisions at a meeting of the Trust shall be by the majority of votes.

10.3. At least seven days previous notice of meeting shall be given to members for ordinary meetings and a day's notice for emergency meeting provided that in case of urgency if the Managing Trustee so thinks fit a resolution may also be passed by circulation.

10.4. In case the votes are equal, the Managing Trustee shall have a casting vote.

10.5. Presence of three votes of Trustee would be the quorum for any meeting.

11.2. REMUNERATION OF TRUSTEES FOR PROFESSIONAL SERVICE

Nothing herein contained shall dis-entitle a Trustee to remuneration due to him by reason of his rendering professional services or for working full time or part time on any of the projects of the Trust.


